1 Introduction and Background

POLICY ANSWERS R&I POLICY making, implementation ANd Support in the WEsteRn BalkanS) is a project funded by the European Union's Horizon Europe research and innovation programme under grant agreement No 101058873.

POLICY ANSWERS (supports policy coordination in the Western Balkans and with the EC and the EU. 14 partner organisations, representing network nodes in the region and EU expert organisations, support policy dialogue through formal meetings (such as ministerial and steering platform and ad-hoc policy meetings), monitoring and agenda setting, capacity building and implementation of the EU's Western Balkan Agenda, as well as the alignment of thematic priorities. The project implements regional pilot activities and offers an information hub based on the westernbalkans-infohub.eu online information platform. The partners provide analytical evidence via monitoring and mapping activities of the stakeholder ecosystem, of the implementation of the Western Balkans Agenda and of the Western Balkans' integration into the European Research Area as well as via strategic foresight.

POLICY ANSWERS also allows for tailored and targeted capacity building activities in the Western Balkans as well as regional alignment of priorities in relation to the digital transformation, the green agenda and towards healthy societies. Pilot activities provide learning opportunities on policy and programme level and reach out to final beneficiaries related to improved academia-industry cooperation, researcher mobility, inclusion of youth in policy processes, promotion of research infrastructures and increased innovation skills in all areas.

This activity is placed in the frame of the targeted capacity building activities (Work Package 3 of the project) in ALBANIA (Task 3.1) which is coordinated by Centre for Social Innovation (ZSI) in cooperation with the National Agency for Research and Innovation (NASRI) as Associated Partner.

Based on an initial mapping carried out by the project WBC-RRI.NET, there are very few good practices for GEPs available Albania. As GEPs are a requirement for participation in Horizon Europe projects for many organisations, it is important to spread the knowledge and support the implementation of GEPs. Some local organisations have received support through SWAFS projects and there are international good practices that can be used (e.g. GENDERACTION, Mind-the-GEP, WBC-RRI.NET, DRIVE project, LeTSGEPs etc.). Yet, knowledge is often now shared in a general awareness of the institutions is about this requirement is low. This is connected also with low awareness of the Charter and Code and the Human Resources Strategy for Researchers (HRS4R) which are needed to reinforce capacity building of higher education institutions in Albania and to increase Albanian participation in the ERA.

The National Strategy for Gender Equality also includes a Specific Objective on the reduction of barriers keeping women, young women and girls away from the labour market and on the improvement of access to decent work (including non-traditional, such as STEM topics/science, technology, engineering, mathematics, etc.) for women, young women and girls in all their diversity (from rural areas, ethnic minorities, persons with disabilities, LBTI+, the elderly, single mothers, survivors of violence/trafficking, girls that are mothers, migrants, and asylum seekers, etc.). Generally, female participation in science as well as in company leadership is increasing and stakeholders are interested.

The Action should support the Association to Horizon Europe and participation in the European Research Area (ERA) as it is a prerequisite to have a GEP for participation in the EU programmes. Good international practices should be used and not just GEPs as a lip service developed.

Upon award of the service contract, the contracting institution will share further information.

2 Description of the Scope and Purpose of the Service

This call requests the provision of the following services for [repeat title of the service], in detail the following work shall be carried out:

- The service provider shall strive to get a strategic commitment of Albanian research performing organisations (RPOs), e.g. public and private universities to ensure gender equality and a safe environment for teachers as well as students at universities.
- This shall include a Memorandum of Cooperation, facilitated by the service provider, creating a network of RPOs who are committed to exchange experiences. The commitment shall include the establishment of responsibilities for GEPs at RPOs (nomination of responsible persons or a





team) to coordinate activities in the areas of gender equality and the fight against gender-based violence and discrimination.

- The employees designated by the RPOs shall receive training and support for data collection and development of GEPs.
- To this end, three workshops shall be organised by the service provider for the participating RPOs, ideally in three different locations in Albania, dealing with the following topics:
 - a. Definition of GEP, tools and resources, data collection
 - b. Interpretation of data and definition of GEP objectives
 - c. Identification and design of adequate measures

GEPs shall be made available in Albanian and English and submitted also to the monitoring exercise of the WBC-RRI.NET project. Lessons learnt shall be exchanged with the UNIGEM project implemented in Bosnia and Herzegovina, Serbia and Montenegro (see http://www.tpo.ba/b/ProjektiEN.html). Regular cooperation with NASRI during the implementation of the activities is encouraged.

Deliverables:

- Schedule of workshops, agenda and participant lists
- Training and briefing materials (in Albanian or English language)
- SMART outcome: at least 8 GEPs developed by mid-2023

Implementation period

October 2022 - June 2023

Expected deadlines and tentative timeline

The service providers are expected to suggest the most suitable methodology and timeline for successful completion of the assignment. A methodological overview needs to be an integral part of the application.
