Today, Belit is a company with a young and dynamic team of over 30 employees and associates. Partnership agreements with IT market leaders such as Microsoft, Oracle, Abbyy and other, numerous references from state institutions, public sector, industry and EU projects, IT Mark and ISO 9001:2008 certification, membership in ICT-NET cluster, inclusion in national Register of innovation activity of Ministry of Education, Science and Technological Development - this is only part of the picture on Belit.
