This report on the activities of the Regional Cooperation Council (RCC) Secretariat is submitted by the Secretary General of the RCC to the RCC Board in line with Article 15 of the Statute of the RCC. It covers the period 24 April – 20 September 2013.

#### I. Executive Summary

The reporting period was characterized by a continuation of the process of undertaking concrete steps in the implementation of the RCC Strategy and Work Programme (SWP) 2011-2013, particularly aimed at an efficient and target-oriented, regionally owned and all-inclusive regional cooperation, by the adoption of RCC's new SWP for the period 2014-2016 and preparations of the South East Europe 2020 Strategy (SEE 2020), as well as by intensive consultations of the RCC Secretary General (SG) with a number of RCC participants.

The RCC Secretariat continued to monitor closely the overall developments in the region, in particular those related to regional cooperation activities in general as well as those within the European Union (EU) enlargement process. There have been many developments in the region proving positive effects of nurturing reconciliation and tolerance, moving forward to solving some of the open and protracted issues and assuming a greater responsibility within the process of European and Euro-Atlantic integration.

Croatia became the 28<sup>th</sup> member state of the EU that deserves wholehearted congratulations. It is the first country from the region to join the EU following the establishment of the RCC, a major success story of the region. This should be a strong impetus for the other enlargement countries to step up their reforms.

The EU Council conclusions on Serbia and Kosovo\* have confirmed the credibility of the EU enlargement policy and that the efforts to solve constructively issues in the end are rewarded. They come following the historic agreement reached between Belgrade and Prishtina, in the context of the dialogue facilitated by the EU, which constitutes a break-through. It should serve as an example and impulse for the entire region, but also an inspiration about how to be resourceful and measured in finding mutually beneficial solutions to open issues. The other enlargement countries are advancing in accordance with their individual merits. Unfortunately, several are lagging behind or are in a stalemate.

These examples show that the EU enlargement policy and regional cooperation are highly complementary. While the former is the strongest anchor of stabilization and reforms, the latter has a key role in ensuring that governments are committed to implementing what has been agreed at the regional level.

Overall, this positive momentum reminds us about the shared purpose agreed 10 years ago, in 2003, at the Thessaloniki Summit. It should also focus our attention to the present duality in the region, whereby the struggle between going forward and lagging behind, absorbs the potential needed to ensure durable results in many vital sectors. The situation is exacerbated by different perceptions about what constitutes real and immediate problems.

The awareness in the region is growing about the need to stimulate economic growth and social stability, upgrade the infrastructure, strengthen the rule of law and further align judicial systems and law enforcement mechanisms to EU and international standards, ensure security and promote freedom of expression.

In other words, durable reforms and policies at the national level should reinforce the role of the EU enlargement policy.

Based on the achievements attained, an in-depth knowledge of the region and its needs, as well as the EU accession requirements, the RCC developed its second SWP for the period 2014-2016. The central pillar of the document or, in more precise terms, of RCC's future work is the SEE 2020. It is a direct response of the region to counter the impact of the economic crisis and is fully in line with the Council conclusions of December 2012 on enlargement and SAP which explicitly tasked RCC to focus on it.

The first draft of the SEE 2020, which resulted from a comprehensive consultative process with the relevant government ministries in SEE was finalized and made available to the public on 30 August 2013. During this process RCC has closely cooperated with regional initiatives in most of the SEE 2020 dimensions, whose contribution has been crucial in the preparation of the SEE 2020. During September 2013, RCC organized in six Western Balkan capitals a series of consultative workshops on the draft SEE 2020 with the intention of engaging comments and discussions from governments, civil society, private sector, donors and other interested parties. These workshops presented the strategy and collected feedback from a wide group of stakeholders. The region is encouraged to make the best use of the SEE 2020 and its Action plan in order to address the economic development priorities and make it more competitive, thereby bringing it closer to the EU. It is expected that the SEEIC meeting (26 September 2013, Sarajevo) will adopt the first draft of the SEE 2020 Strategy and review the draft of the Ministerial Declaration for its adoption by the SEE 2020 ministers of economy on 21 November 2013 in Sarajevo. In this context, the RCC with its recognized role in monitoring and guiding the regional cooperation process takes carefully into account regional interests and feeds policy implementation within its participants from the region.

The RCC benefited enormously from the strategic synergy with the South East Europe Cooperation Process (SEECP) Chairmanship-in-Office (C-i-O) held by The Former Yugoslav Republic of Macedonia in 2012-2013. Its leadership in strengthening regional cooperation and progress in SEE augmented RCC's capacities to pursue its mission in the best interest of the SEE participants. The RCC is looking forward to further enhance the coordination and cooperation with the Romanian SEECP C-i-O for 2013-2014 which has been confirmed on the occasion of the recent consultations between the RCC SG and Romanian MFA.

The meetings of the SEECP Speakers of Parliaments, Political Directors and MFAs held at the end of May 2013 in Ohrid resulted with several very important outcomes: the Speakers of Parliaments of the SEECP Parliamentary States decided to establish a SEECP Parliamentary Assembly and recommended its inauguration during the Romanian SEECP C-i-O for 2013–2014; the SEECP MFAs approved the SEECP Ohrid Declaration and the Joint Statement "Solidarity in Action" – devoted to disaster risk reduction and climate change adaptation. The Summit of the SEECP Heads of State/Government, due to the different positions of certain SEECP Participating States regarding the intention of the SEECP C-i-O to invite the President of Kosovo\* to attend the event as a special guest of the C-i-O and the last minute decision of several Heads of State not to participate at the event, has been cancelled by the SEECP C-i-O.

The 5<sup>th</sup> Annual Meeting of the RCC endorsed the RCC SWP 2014-2016 focused on SEE 2020, and the Annual report on its activities over the past 12 months, which was also approved by the SEECP MFAs. This represents a clear political commitment to improve the socio-economic conditions in SEE.

The participants of the SEECP high-level events and the RCC Annual meeting praised the all-inclusive framework ensured within the RCC as well as reaffirmed their full support to RCC's role for guiding and monitoring regional cooperation.

As a practical follow-up of the meeting, organized by the RCC in Strasbourg in April 2013, between the MFAs of the W. Balkans and with the participation of European Commissioner for Enlargement and Neighbourhood policy, Montenegro launched the W. Balkans 6 Initiative aimed at intensifying the EU integration process of the W. Balkans. At the consultative meeting of the Political Directors from the MFAs of the WB 6 + 1 (including Croatia) held on 16 July 2013 in Budva, the RCC SG recalled the role of RCC as all-inclusive and regionally owned framework for coordinating regional cooperation in SEE and proposed participation of Croatia in the initiative, the possibility of introducing regular meetings at the level of Prime Minister/Deputy Prime Ministers responsible for EU integration in order to hone the decision making process within the Western Balkans Investment Framework, as well as expressed readiness of the RCC to become the executive arm of the Initiative, while continuing to be the operational arm of the SEECP. The next meeting of the initiative at the level of MFAs in the 6+2 format with participation of Croatia, Slovenia, and the European Commissioner for Enlargement and Neighbourhood policy EC and RCC SG will take place on 26 September 2013 in New York.

RCC's continuing involvement in the current and incoming multi-beneficiary IPA frameworks will shape its capacity to use a strategy-based approach and deliver pertinent results in the region. In this context, the RCC Secretariat presented comments (upon invitation of EC) to the draft Instrument for Pre-Accession Assistance Multi-country Strategy Paper 2014–2020 and expressed appreciation for the prominent role given to the RCC in the document and the indication of EU support to the operational budget of the RCC needed for the implementation of its SWP 2014-2016.

In the framework of the implementation of the SWP 2011-2013 further concrete results have been achieved.

A SEEIC Working Group on Competitiveness has been established and the Women Entrepreneurship – A Job Creation engine in SEE made significant progress in the development of the comprehensive regional database of women entrepreneurship.

The  $8^{th}$  Steering Committee of the Western Balkans Investment Framework (WBIF) approved 15 projects in the amount of  $\in$  15 million of grants for key infrastructures in the areas of energy, transport, health, education and judicial facilities.

A Letter of Intent on Joint Service Provision Area initiative has been signed, thus confirming the willingness of the national authorities to engage their full capacities towards strengthening regional cooperation in air traffic in SEE.

The preparation started for a Regional Strategy in the field of Justice and Home Affairs for 2014–2020 and to that end consultations were held with relevant representatives of the EU institutions and several countries of the region.

The regional conference of the Ministers of Interior and Ministers of Justice agreed on the necessity to work on intensifying the activities of the regional expert teams monitoring regional co-operation in criminal matters. The Regional conference of the Brdo Process established an informal high-level expert platform consisting of heads of services for EU integration in the field of home affairs.

The implementation of the SEEMIC Project continued by organising and executing planned activities related to the training and installing the PGP software in 9 out of 15 SEEMIC members.

The Western Balkans Platform on Education and Training (WB PET) Ministerial Meeting adopted a Roadmap of its future activities at national and regional level.

The work on the Regional Research and Development Strategy for Innovation for the Western Balkans has been completed and its adoption is expected at the Ministerial Conference scheduled for 24-25 October 2013 in Zagreb.

The 5<sup>th</sup> Meeting of the TFCS noted the progress in the implementation of the activities related to the EU €0.5 mill Grant for Sustaining the Rehabilitation of Cultural Heritage and the EU €2.8 mill Grant for Preserving and Restoring Cultural Heritage in the Western Balkans.

In order to seize the positive momentum and turn the tides against the current multifaceted consequences of the economic crisis in SEE, the RCC focused on prioritizing its areas of work, displaying flexibility in its approach, increasing visibility for the general public and exhibiting a constant vision of the ultimate goal.

The second edition of the Academy on Media Law in SEE focused on issues of media pluralism, public service broadcasting and the freedom of the media on the Internet. The Academy seeks to enhance cooperation in the development and implementation of progressive media legislation in SEE in line with international and European media standards.

#### II. General and institutional aspects of the RCC Secretariat's activities

#### RCC Board Meeting

The 20<sup>th</sup> meeting of the RCC Board, held on 25 April 2013 in Sarajevo, was attended by the representatives of all Board participants, with the exception of Ireland, Latvia, Moldova and Norway.

The RCC Board meeting adopted the following decisions: 1) On the approval of the Financial Report of the RCC Secretary General for the year 2012 and 2) On the amendment to the Budget of the RCC Secretariat for the year 2013.

The RCC Board also: 1) accepted the Annual Report of the Secretary General on regional cooperation in SEE for 2012 – 2013; 2) approved the Report of the RCC Secretary General on the activities of the RCC Secretariat and on the implementation of the RCC SWP 2011-2013 for the period 16 February – 10 April 2013; 3) adopted the RCC Strategy and Work Programme for the period 2014 – 2016; 4) adopted the Statute of the RCC (Annex II) of the Joint Declaration on the Establishment of the RCC, with the proposed suggestions and 5) gave its consent for signing the Memorandum of Understanding between the RCC and the ASEAN Foundation.

Following the position expressed by the Former Yugoslav Republic of Macedonia on the Conclusions of the Ad-hoc Working Group of the RCC Board participants from SEE, held in Sarajevo on 20-21 March 2013, consensus has been reached among participants from SEE establishing the level and the distribution of the contributions to the budget of the RCC Secretariat for 2014-2016.

#### Coordination between the SEECP and the RCC

The 12<sup>th</sup> Coordination meeting, held on 24 April 2013 in Sarajevo, gathered representatives of the SEECP Troika – the SEECP Chairmanship-in-Office (C-i-O) for the period 2012-2013, the incoming SEECP C-i-O Romania and the previous SEECP C-i-O Republic of Serbia, the RCC Secretariat and the EU institutions.

The Agenda of the meeting included: 1) Information on the most important activities related to the priorities of the SEECP C-i-O for the period 2012-2013 and of the RCC Secretariat, in particular those pertaining to the implementation of its SWP 2011-2013; 2) Exchange of views regarding the draft RCC SWP 2014 - 2016 and 3) Further steps in the process of streamlining of regional taskforces and initiatives in SEE.

The Coordination meeting in its conclusions supported the draft RCC SWP 2014-2016 and agreed that the item agenda of the meeting referring to the further steps in the process of streamlining of the regional taskforces and initiatives in SEE shall no longer be needed as this issue has been appropriately addressed in the SWP 2014-2016.

On the occasion of their meeting in Bucharest, the RCC SG and the MFA of the Romanian SEECP C-i-O exchanged views on the most important developments in the region and its European perspectives and the role of regional cooperation in this sense. Forthcoming activities related to the SEECP C-i-O were also discussed, in particular the informal meeting of the SEECP MFAs scheduled for 27 September 2013 in New York, at which the RCC SG has been invited to participate.

#### RCC Annual Meeting

The 5<sup>th</sup> Annual Meeting of RCC took place on 30 May 2013 in Ohrid, back to back with the high level meetings of the SEECP. The meeting was co-chaired, on behalf of the SEECP C-i-O for 2012-2013, by the Minister of Foreign Affairs and, on behalf of the RCC, by the RCC SG. The meeting was attended by the RCC participants and, for the first time, upon the invitation of the RCC SG and in coordination with the SEECP C-i-O, representatives of the regional organizations and initiatives.

The Agenda of the meeting included introductory remarks by the MFA of the SEECP C-i-O for 2012-2013 and by the RCC SG; exchange of views on the developments in regional cooperation in SEE; RCC SWP 2014-2016 – presentation and endorsement; the Annual Report of the Secretary General of the RCC on regional cooperation in SEE for the period 15 May 2012–25 April 2013 – presentation and endorsement.

The RCC's participants that took part in the discussion recurrently emphasized their commitments to regional cooperation and good-neighbourly relations in SEE as essential requirements for the region's European and Euro-Atlantic integration. They highlighted the all-inclusive framework ensured within the RCC, assessing the decision of the RCC Board on the effective participation of Kosovo\* in RCC as a great success and a milestone in the regional cooperation in SEE and expressed hope that this example would be followed by other regional cooperation formats, including the SEECP. The RCC's participants appreciated the work of the RCC, the results achieved in each priority area of cooperation and in the context of successful implementation of SWP 2011-2013. They welcomed the RCC SWP 2014 -2016 and RCC's efforts in developing the SEE 2020. They welcomed the increased focus on the SEE 2020, as a key priority for RCC in the coming years and called upon all the governments to make necessary steps to ensure that the national headline targets of the SEE 2020 will be met. The RCC's participants gave full support to the RCC SG and the RCC Secretariat team for their work and genuine efforts to strengthen the regional cooperation through the ambitious new SWP and welcomed the initiative of the RCC SG to invite the heads of the regional organizations and initiatives to the RCC Annual Meeting.

The incoming SEECP C-i-O announced that it will focus its activities on those areas where tangible progress is achievable, especially in view of strengthening the SEECP and make it more efficient and focused-oriented.

The meeting endorsed the RCC SWP for the period 2014-2016 and the Annual Report of the Secretary General of the Regional Cooperation Council on regional cooperation in SEE for the period 15 May 2012 – 25 April 2013.

### Participation of the RCC Secretariat delegation at the high-level meetings of the SEECP C-i-O for 2012-2013, held in the period 29 – 31 May 2013 in Ohrid

The SEECP high-level events, marking the end of the SEECP C-i-O for the period 2012 - 2013, consisted of the fifth meeting of the SEECP Political Directors (PDs), tenth Conference of the SEECP Speakers of Parliaments and the Formal meeting of the Ministers of Foreign Affairs (MFAs).

The Summit of the SEECP Heads of State/Government, due to the different positions of certain SEECP Participating States regarding the intention of the SEECP C-i-O to invite the President of Kosovo\* to attend the event as a special guest of the C-i-O and the last minute decision of several Heads of State not to participate at the event, has been cancelled by the SEECP C-i-O.

The delegations of the SEECP Participating States emphasized the need for a deeper regional cooperation within SEECP and RCC as a response to the adverse impact of the economic crisis in the countries of the region. They appreciated the results achieved by the RCC in the implementation of its SWP 2011-2013, the work done in developing the RCC SWP 2014 – 2016 and the SEE 2020. They also praised the all-inclusive framework ensured within the RCC, with several delegations expressing support for the inclusion of Kosovo\* in SEECP. The incoming SEECP C-i-O pointed out, inter alia, that during its C-i-O the main focus will be on retaining the relevance of SEECP as the main political forum for regional dialogue, on promoting key areas of cooperation in SEE and on enhancing cooperation with RCC.

The SEECP MFAs approved the SEECP Ohrid Declaration and "Solidarity in Action" Joint Statement, the Annual Report of the RCC Secretary General on regional cooperation in South East Europe 2012-2013, the RCC SWP for the period 2014-2016 and Romania's Chairmanship-in-Office of the SEECP for the term 2013-2014.

#### Consultations of the RCC Secretary General with RCC participants

The RCC SG, within the permanent dialogue with the RCC participants, held meetings and consultations with high-level officials of Montenegro, Croatia, Austria, Ireland, Bulgaria, The Former Yugoslav Republic of Macedonia, EU institutions such as the EC and EP, OSCE, UNDP and CoE.

The RCC SG in the discussions placed an overt emphasis on the SEE 2020 and the need of an appropriate political support by the governments of the W. Balkans in the process of its adoption and implementation. The success of the SEE 2020 will require a broad political engagement of the national governments and therefore it will be necessary to raise the political importance of SEE 2020 and that the Prime-Ministers are fully informed and committed to work in this direction.

As a practical follow-up of the meeting, organized by the RCC in Strasbourg in April 2013, between the MFAs of the W. Balkans and with the participation of European Commissioner for Enlargement and Neighbourhood policy, Montenegro launched the W. Balkans 6 Initiative aimed at intensifying the EU integration process of the W. Balkans. At the consultative meeting of the Political Directors from the MFAs of the WB 6 + 1 (including Croatia) held on 16 July 2013 in Budva, the RCC SG recalled the role of RCC as all-inclusive and regionally owned framework for coordinating regional cooperation in SEE and proposed participation of Croatia in the initiative, the possibility of introducing regular meetings at the level of Prime Minister/Deputy Prime Ministers responsible for EU integration in order to hone the decision making process within the Western Balkans Investment Framework, as well as expressed readiness of the RCC to become the executive arm of the Initiative, while continuing to be the operational arm of the SEECP. The MFA's representatives generally welcomed the idea of

cooperating in this format, appreciated Croatia's participation and readiness to share its experience acquired in the course of the accession process to the EU, commended the idea for the RCC to become the executive arm of the initiative while continuing to be the operational arm of the SEECP and referred to SEE 2020 as a possible backbone of cooperation within the W. Balkans 6+1.

The next meeting of the initiative at the level of MFAs in the 6+2 format with participation of Croatia, Slovenia, and the European Commissioner for Enlargement and Neighbourhood policy EC and RCC SG will take place on 26 September 2013 in New York.

#### Cooperation with the EU and other Brussels-based institutions

The RCC Liaison Office (LO) in Brussels continued with its contribution to the implementation of the RCC SWP 2011-2013, the preparation of the RCC SWP 2014-2016 and the SEE 2020, as well as to monitor closely the developments of the EU Enlargement process.

The RCC LO had a number of meetings with different representatives of the EU institutions and bodies, ambassadors and diplomats of the missions of the countries of SEE accredited to the EU and organized a number of meetings for the RCC SG with high-level officials of the EU and other Brussels-based institutions, including the Commissioner for Enlargement, the Commissioner for International Cooperation, Humanitarian Aid and Crisis Response, the Director General for Enlargement and the Deputy Director General for Enlargement in the EC, as well as the Directors General of the enlargement countries responsible for civil protection.

At the meeting with the Commissioner for International Cooperation, Humanitarian Aid and Crisis Response the cooperation between the RCC and the EC in the area of disaster prevention, preparedness and response in SEE, in light of the preparations of the summit of the SEECP in Ohrid and in particular the draft Joint Statement "Solidarity in Action" devoted to disaster risk reduction and climate change adaptation, was discussed.

At the meetings with the Director General and Deputy Director for Enlargement the ongoing work on the SEE 2020 Strategy, the EU Enlargement dynamics and the utility of further aligning RCC's role with the EU enlargement agenda, the future financing of the RCC Secretariat, the draft Instrument for Pre-Accession Assistance Multi-country Strategy Paper 2014 – 2020 and RCC's proposals in that respect were discussed. The RCC SG proposed to include a reference to the SEE 2020 in the upcoming EC Enlargement Strategy Paper and country progress reports and in IPA County Strategy Papers, as well as noted his intentions to facilitate the economic governance process in the W. Balkans possibly in the framework of W. Balkans 6+1 format.

At the briefings held separately for the Working Group on the W. Balkans of the Foreign Policy Committee of the EP and for the SEE Ambassadors to the EU, the RCC SG referred to the developments in the region and the progresses made within the European agendas, while underlining the significance of the EU Council conclusions and the decisions of the European Council on Serbia and Kosovo\*. The representatives were also informed about the results of

the SEECP high-level meetings in Ohrid, the new RCC SWP 2014-2016 and the preparations of the SEE 2020, as well as on the Montenegrin initiative W. Balkans 6+1.

At the IPA Multi-Beneficiary Coordination Meeting, the status of the preparations for the IPA II programming as well as the multi-beneficiary (MB) project implementation and evaluation of variety of MB IPA I activities were discussed. In this context, the RCC Secretariat presented comments (upon invitation of EC) to the draft Instrument for Pre-Accession Assistance Multi-country Strategy Paper 2014–2020 and expressed appreciation for the prominent role given to the RCC in the document and the indication of EU support to the operational budget of the RCC needed for the implementation of its SWP 2014-2016.

The EU Council conclusions on Serbia and Kosovo\* have confirmed the credibility of the EU enlargement policy and that the efforts to solve constructively issues in the end are rewarded. They come following the historic agreement reached between Belgrade and Prishtina, in the context of the dialogue facilitated by the EU, which constitutes a break-through. It should serve as an example and impulse for the entire region, but also an inspiration about how to be resourceful and measured in finding mutually beneficial solutions to open issues. The other enlargement countries are advancing in accordance with their individual merits. Unfortunately, several are lagging behind or are in a stalemate.

#### Regional cooperation in the field of media

The second Academy on Media Law in SEE was organized under the auspices of the RCC and in cooperation with the Friedrich Ebert Foundation, the OSCE Representative on Freedom of the Media, OSCE field operations in SEE[1], the European Broadcasting Union, the European Association of Public Service Media in SEE and ARTICLE 19: Global Campaign for Free Expression. The participants proposed ways to increase the pluralism of content and views in the region and the independence and accountability of public service media. They also emphasised that a high number of media outlets in the region does not equal the plurality of views, content and sources. Although viewers can choose between plenty of channels, political and economic interests prevent pluralism of views. Therefore, the Academy recommended that the public service media reach out to stakeholders, including parliamentarians, media councils and civil society, in order to better promote the role of public service broadcasters and the public service remit.

Agreeing on the lack of qualitative data on media pluralism, the participants suggested surveys to evaluate both internal pluralism, with public service broadcasters to assess pluralism of content within public media, and external pluralism, to assess pluralism of views in a particular country. Furthermore, the Academy discussed the ownership structure of the media, state advertising, new, online media, its contents, legal framework and responsibilities, credibility, violations, etc.

The SEE documentary "How do I see my neighbour", supported by the EC, CEI and RCC was completed and aired on public service broadcasters in SEE in April/May. A conference on strategic communication between security institutions and media in SE E was co-organized by the RCC Secretariat in Skopje, together with RACVIAC, Ministry of Defence, NATO and Croatian Radio-Television.

#### Communication activities

The RCC Secretariat continued to advance the organization's mission, focusing on communication aspects of the SEE 2020, such as press coverage of the SEE 2020 outreach, RCC's 5<sup>th</sup> Annual Meeting, briefing of the diplomatic community in Sarajevo etc. In total, the RCC Secretariat organized press coverage of 19 different events.

In the reporting period, to the knowledge of/available to the RCC Secretariat, 597 articles, interviews and statements on the RCC were published in SEE and international media, bringing the total to 5,488 available articles published since the beginning of operations of the RCC Secretariat. The same period witnessed 1,571,542 hits, 439,433 page views and 48,124 visits of the website, bringing the total to some 16,412,610 hits, 5,308,443 page views and 517,689 visits over the past five years since the website statistics has been gathered. The RCC currently also has 484 tweets and 459 followers at its Twitter account. Three issues of the RCC newsletter were published, devoted to: the inclusive growth pillar of SEE 2020, Regional Cooperation Council's Annual Meeting 2013, and justice, home affairs and security cooperation in SEE, featuring 33 prominent contributors. It was circulated to an audience of almost 3,000 subscribers.

#### Evaluation of general and institutional aspects

The reporting period was characterized by a continuation of the process of undertaking concrete steps in the context of the implementation of the RCC SWP 2011-2013, particularly aimed at the efficient and target-oriented, regionally owned and all-inclusive regional cooperation. In parallel, the RCC Secretariat was fully engaged with preparatory activities for the RCC SWP 2014-2016 and for the SEE 2020. In order to maintain the momentum of the development of regional cooperation and continue with the affirmation of the principle of regional ownership as well as highlighting the importance of moving towards regional responsibility, the strategic character of relations between the SEECP and the RCC remains pivotal.

Drawing on the successful cooperation with the previous as well as incumbent SEECP C-i-O, the regular Coordination meetings of the SEECP Troika and the RCC Secretariat with the participation of the EU representatives proved to be a very useful tool in providing guidance and enhancing overall coordination.

In light of the new tasks ahead of the RCC Secretariat, in particular related to the implementation of the SEE 2020 Strategy and RCC SWP 2014–2016, the company Moore Stephens LLP contracted by the EC carried out in July 2013 a compliance assessment of the RCC Secretariat to determine whether it fulfils the criteria established for the implementation of tasks in joint management mode. The assessment involved performing a compliance analysis of RCC to assess whether its rules and procedures apply standards which offer guarantees equivalent to internationally accepted practice. The RCC Secretariat is expecting the report to be released by the aforementioned company upon its completion.

#### III. Priority areas of the RCC activities

#### 1. Economic and Social Development

#### Investment and Business Enabling Environment

The RCC/SEEIC team held a series of consultative meetings during May and June 2013 with Country Economic Teams (on a deputy/assistant minister level and with a number of line ministries involved in the development of the SEE 2020 pillars, as well as National IPA Coordinator representatives of the W. Balkans) aimed at strengthening intra-governmental coordination on the development and implementation of the SEE 2020. The meetings discussed the activities related to the SEE 2020 development, its future implementation and monitoring, as well as the links with the national reform agenda and the IPA II Strategic Framework.

The first meeting of the SEE 2020 Coordination Board, composed of representatives of the RCC Secretariat and the Dimension coordinators (Vienna on 23 May 2013), exchanged information between the RCC Secretariat and the Dimension coordinators on the current state of play and the level of progress achieved in the development of the SEE 2020 and individual inputs per each dimension.

The 13<sup>th</sup> SEEIC Meeting (Sarajevo, 19 June 2013), reviewed the outline and development process of the SEE 2020, based on the inputs contributed thus far to each pillar and discussed the future governance and monitoring mechanisms of the Strategy. A SEEIC Working Group on Competitiveness has been established, with a goal to support the development of the Competitiveness Dimension of the Sustainable Growth Pillar of the SEE 2020, as well as to take part in future implementation of the New Generation Competitiveness Initiative project.

The first draft of the SEE 2020, which resulted from a comprehensive consultative process with the relevant government ministries in seven countries in SEE was finalized and made available to the public on 30 August 2013. During this process, the RCC Secretariat has closely cooperated with regional initiatives in most of the SEE2020 dimensions, whose contribution has been crucial in the preparation of the SEE2020 strategy.

During September 2013, the RCC Secretariat organized in six W. Balkan capitals a series of consultative workshops on the draft SEE 2020 with the intention of engaging comments and discussions from governments, civil society, private sector, donors and other interested parties. These workshops presented the strategy and collected feedback from a wide group of stakeholders.

Women Entrepreneurship – A Job Creation engine in SEE (financed by the Kingdom of Sweden, coordinated by the RCC and executed by SEECEL and GTF) made a significant progress in the development of the comprehensive regional database of women entrepreneurship. In the area of policy making, piloting of the second generation indicators for the women entrepreneurship is in the final stage, with expected national dissemination of results in the autumn 2013.

#### Access to Finance

The 8<sup>th</sup> Steering Committee of the Western Balkans Investment Framework (WBIF), amongst the investment projects and sectoral studies submitted for approval under the WBIF round

nine, approved 15 projects in the amount of  $\in$  15 million of grants for key infrastructures in the areas of energy, transport, health, education and judicial facilities.

The 2<sup>nd</sup> meeting of the Platform Advisory Group (PAG) of the Western Balkan Enterprise Development and Innovation Facility (EDIF), held back to back with the WBIF Steering Committee meeting, updated PAG members on the status of various segments of EDIF<sup>1</sup> and outlined next steps for its stakeholders. It was noted that at least two funds of the EDIF – the Enterprise Expansion Fund (ENEF) and the Guarantee facility should become operational by the end of 2013.

#### Mainstreaming employment and social agenda into economic reform deliberations

Efforts have focused on preparing the first draft of the employment dimension of the SEE 2020, based on the outcomes of the meetings of the inclusive growth working group that the RCC Secretariat organized in the course of 2013. Increased labour mobility, better labour market governance and the promotion of social economy initiatives are the three main areas, in which regional cooperation will focus to foster employment creation in the context of SEE 2020.

Labour mobility is an important tool for strengthening cooperation and integration among countries, while promoting employment and the best use of cross-country labour resources. Flexicurity, labour administration capacities, reliable data, matching skills and jobs, as well as promoting the employment of disadvantaged groups are all in the focus of regional cooperation on employment.

The development of social economy is seen as an important avenue for promoting employment in SEE through setting up of enabling legal frameworks, policies, strategies and actions, focusing especially on incentives that would give social economy initiatives a greater chance of succeeding. Having identified Cooperatives Europe as an important and interested partner in this respect, the RCC Secretariat participated at their workshop on cooperative enterprises in SEE, with a special emphasis on regional cooperation that can stimulate communication, best practice exchange on enabling legal frameworks, policies, strategies and actions on social economy development.

The RCC Secretariat participated at a meeting, organized by Industry All Europe and Friedrich Ebert Foundation, on industrial policy in SEE, aimed at improving the industrial trade union's knowledge and competences on industrial policy in order to sharpen their arguments and policy proposals vis-à-vis the revitalization of the industry in SEE as a crucial factor for growth and jobs.

The first draft of the health dimension chapter of the SEE 2020 was discussed at the SEE

#### Public Health

Health Network meeting. With the general aim to improve the health and well-being of all those living in SEE, the actions under the health dimension aim to harmonize the cross-border public health and public health services legislation, standards, procedures and developing mutual recognition and trust, strengthen institutions and improve governance of the health sector and strengthen the delivery of universal and high quality health promoting services.

The regional workshop 'Health and Health Policy', organized by the Ministry of Health of Croatia and University of Zagreb medical school, served as another opportunity to discuss these priorities in concrete terms.

#### **Promoting Information Society**

Under the coordination of the eSEE Secretariat, the countries of the region have proposed a set of regional ICT (Information and Communication Technologies) priorities for the SEE 2020, which include the promotion of e-government and online public services, the development of regional broadband infrastructure, advancement of network security and data protection, ICT training for public administration and citizens, and ICT for e-inclusion of marginalized groups.

#### Other

On the occasion of the meeting of the Business Advisory Council for South-eastern Europe and Eurasia (BACSEE), RCC and BACSEE agreed to strengthen their working relationship in the context of the SEE 2020 preparation and implementation.

The 13<sup>th</sup> meeting of the forum of the Adriatic and Ionian Chambers of Commerce (AIC) discussed the preparation of the EU Strategy for the Adriatic and Ionian macro-region and exchanged views on the Action Plan for the Strategy with the focus on the contribution of chambers of commerce in the process. The RCC Secretariat and the AIC Forum will seek to ensure permanent synergies in the development and implementation of this Strategy.

#### 2. Energy and Infrastructure

#### Energy

The ECS targets in relation to energy efficiency and renewable energy sources were integrated into the SEE 2020 as the crucial components of the Resource Efficiency Dimension of the SEE 2020 Sustainable Growth Pillar. The RCC Secretariat and the ECS agreed on joint activities on strengthening cooperation with and between the members of regional Parliaments from the parliamentary committees in charge of energy issues and jointly organized the workshop that gathered Parliamentarians from the region with the main goals to raise awareness on Energy Community and necessary energy sector reforms as well as facilitate law-making process. Tailor-made workshops will be organized as the follow-up of this inaugural event that took place at the ECS premises in Vienna. Furthermore, two organizations are considering joint activities necessary to support improvement of energy statistics in the countries from the region.

The RCC Secretariat, Tuzla Fair and Association for Solar Energy of BiH co-organized an International Energy Conference ENERGA 2013. The RCC Secretariat also organized jointly with the Serbian Society of Thermal Engineers the 4<sup>th</sup> Regional Conference on Industrial Energy and Environmental Protection in SEE. These events enhanced cooperation and consultations with relevant national authorities and provided some inputs for drafting the Resource Efficiency Dimension of the SEE 2020 Sustainable Growth Pillar. The RCC also supported implementation of the regional initiative "Strengthening the Public Dialogue on the Sustainable Use of Energy in South East Europe".

The RCC Secretariat has also sustained close cooperation with the CEI and the Short Term Expert (STE) engaged within the EU funded project on Improving Cooperation in SEE by

Actions for Strengthening the RCC in order to support preparations of national stakeholders' meetings and Sector Stakeholders Conference.

#### **Transport**

The RCC Secretariat has intensified consultations with the Implementation of Single European Sky (ISIS) Programme Secretariat, JSPA Initiative, as well as other interested stakeholders related to the Study on the Importance of Air Transport Sector. RCC is in the process of identifying the lead IFI in the application to be re-submitted for the 10<sup>th</sup> WBIF call for proposals.

The RCC Secretariat continued the preparatory activities, together with the Association of Consulting Engineers of B&H (ACE B&H), for organizing the Conference on Railways in Sarajevo on 26-27 September 2013. This event will discuss development of railway transportation system, infrastructure needs and financial availabilities as well as the legal and institutional railway reforms and horizontal requirements in this field.

The RCC Secretariat is making efforts to promote more actively a Public Private Partnerships (PPP) as an alternative way of financing infrastructure projects. To this aim the RCC Secretariat continued the preparations for organizing the Conference on Better Economic Development in SEE which is scheduled to be held in Sarajevo, on 10 October 2013. The event intends to support the establishment of a PPP Centre in Sarajevo which will aim to create conditions for promotion and more efficient use of local expertise in the area of PPP, as well as to improve business environment in order to attract investments needed to ensure the financial sustainability of the regional infrastructure in line with the SEE 2020.

An intensive coordination among all relevant parties and regional initiatives dealing with transport issues has been carried out. The RCC Secretariat, in coordination with SEETO and JSPA representatives, supported with pertinent guidelines and materials the consultant responsible for drafting the transport part within the Resource Efficiency Dimension of the SEE 2020.

#### Environment

The International Commission for the Protection of Danube River (ICPDR) and the RCC Secretariat co-organized the 11<sup>th</sup> Standing Working Group Meeting of the ICPDR, which provided guidance and prepared decisions for the further work of the ICPDR including its direct involvement in the implementation of the EU Strategy for the Danube Region (EUSDR).

Following the SEEFCCA Network Coordinators meeting, jointly organized by the RCC Secretariat and the SEE Forum on Climate Change Adaptation (SEEFCCA), the RCC Secretariat intensified cooperation with the SEEFCCA and provided inputs relevant for the environmental sub-dimension of the Resource Efficiency Dimension of the SEE 2020 Sustainable Growth Pillar. The RCC Secretariat has also maintained close cooperation with the Regional Environmental Center (REC) as the Dimension Coordinator of the Resource Efficiency Dimension within the SEE 2020.

At the International Conference "Towards a low carbon economy in the Danube Region: State of affairs, challenges and prospects", the RCC Secretariat presented the activities related to the preparation of the Resource Efficiency Dimension of the SEE 2020 Sustainable Growth Pillar and provided inputs and commitments from relevant partners in this endeavour.

Intensive cooperation has been established with the consultant that supported drafting of the SEE 2020 and consultative workshops that created opportunities to present Resource Efficiency Dimension of the SEE 2020 Sustainable Growth Pillar to the wider audience and provide additional inputs primarily from the civil society and business community.

#### 3. Justice and Home Affairs

#### Strategic coordination: events and actions

Several meetings with the SEE 2020 dimension coordinators RAI, NALAS, GIZ and ECDR took place in order to define the main objectives in the field of public administration and effective public services, fight against corruption as well as in the field of judiciary. All parties involved provided their input for the SEE 2020. Following NALAS's request for the RCC's assistance in establishing and strengthening links with the national authorities and respective line ministries, RCC is holding intensive talks with ReSPA, which is seen as the main and adequate partner in this process. Several bilateral consultations were held with different state institutions in the region in order to discuss SEE 2020 prior to its final adoption.

The preparation of the Regional Strategy in the field of Justice and Home Affairs for the period of 2014 - 2020 is in the pipeline and to that end consultations were held with relevant representatives of the EU institutions, as well as with several countries of the region.

The Regional conference of the Brdo Process devoted a special attention to the issues of increased mixed migration flows leading to Western Europe via Balkan route, international protection seekers and achievements of the EU Action on Migratory Pressures. The problem of arms trafficking and the need to strengthen cooperation in this area was also underlined. Both implemented and envisaged activities in the framework of the Brdo Process were presented as a valuable tool for the countries of the region to be used when bridging the crucial period on their way to the EU. In view of ensuring coordinated/coherent EU assistance within the fulfilment of conditions under accession Chapter 24, an informal high-level expert platform consisting of heads of services for EU integration in the field of home affairs was set up. The RCC Secretariat is a partner in the high-level expert platform and cooperates with Slovenia closely. The conference also initiated the idea of a joint platform for exchanging information on migration which could prevent the abuse of visa liberalisation for Western Balkans.

The 5<sup>th</sup> Meeting of the Steering Group of EU Strategy for Danube Region-Priority Area 11 discussed the state of play of the EUSDR PA 11 and adopted some important documents. The meeting took note of developments in the projects related to Danube Information Centres, Danube Assessment Centre, Working Group "Southeast" and Rule of Law as well as European Anticorruption Training (EACT). On this occasion, the technical assistance facility was presented as well as a proposal for cooperation from PA 1A which will target better coordination of law enforcement and customs in order to simplify control procedures on the Danube river.

#### Management of the migration flows

As a follow up to the Brdo process, the RCC Secretariat held a meeting with the representative of ICMPD, which received a mandate at the Brdo process ministerial conference to hold a Secretariat of the Western Balkans Migration Network. The problem is financing the operation of the network. The creation of such a network is also present in

national agendas, which in turn has to be communicated to the EC for inclusion in the regional IPA II. A discussion was also raised on the issue how could ICMPD contribute to the future RCC regional strategy in the field of justice and home affairs.

#### Fighting organized crime

The OSCE/TNT/SPMU Conference on Prevention of Illicit Drug Trade on Internet offered a completely new perspective on the misuse of internet and, in particular, use of dark internet for provision of drugs, weapons and other criminal activities. The participants agreed that its use is rapidly expanding and represents a serious security threat. The conference served also as an opportunity for bilateral meetings with representatives of anti-drug units of the RCC Participants.

#### Strengthening judicial and prosecutorial cooperation in criminal matters

The RCC Secretariat suggested regular annual meetings between Chief Public Prosecutors and Chiefs of the Police, which should provide enhanced cooperation, make gap analyses and eliminate all obstacles for the cooperation. Therefore, the RCC Secretariat works closely with the PCC-SEE Secretariat to develop an idea for including prosecutors in all PCC-SEE activities. The representatives of both organizations discussed all the possibilities, including the financing of the prosecutor's inclusion in the activities of the PCC SEE. One of ideas was financing through the SDC funds, but this matter would need to be further discussed. The meeting was also used to discuss Organized Crime Threat Assessment for the SEE and involvement of the PCC SEE in the RCC Regional Strategy.

The first meeting of the Regional Judiciary Policy Network gathered representatives of the Parliaments, Judicial Councils and the Ministries of Justice and discussed the opportunities for institutionalisation of cooperation on policy issues related to judicial reforms. While the general need was formulated, further discussions have to take place in order to agree on the structure and functions of such form of cooperation.

#### Supporting existing initiatives in the area of the fight against corruption

The RCC Secretariat organized several meetings with the management of Regional Anti-Corruption Initiative to discuss and shape the first proposals related to the participation of RAI in the SEE 2020 as Dimension Coordinator for Anti-Corruption. Outline of the Anti-corruption Pillar Dimension was prepared during these meetings. The RCC Secretariat participated at the high-level meeting "Regional Anti-Corruption Cooperation in SEE: the Way Ahead" which was organized by RAI and focused on the signature of the Protocol Amending the Memorandum of Understanding Concerning Cooperation in Fighting Corruption through SEE Anti-corruption initiative.

#### Cooperation in civil and commercial matters

The RCC Secretariat and GIZ organized several working meetings dedicated to mutual cooperation of partners and regional negotiations in the area of civil and commercial matters.

#### 4. Security Cooperation

#### Facilitate and support development of regional mechanisms for security cooperation

The RCC Secretariat continued the implementation of the SEEMIC Project by organising and executing the training and installation of the PGP software. As a result, the software was installed in 9 out of 15 SEEMIC members.

The RCC Secretariat co-organised with the Croatian MI the SEEMIC Expert Working Group (EWG) meeting in preparation of the 5<sup>th</sup> SEEMIC Conference to be held in Split on 24-26 September 2013 and developing the second Regional Intelligence Analysis.

The RCC Secretariat will also co-organize together with the Croatian Parliament Domestic and National Security Committee the first informal meeting of the Chairmen of the National Security/Defence Committees of the Parliaments of the SEE RCC Participants. The meeting will take place as a back-to-back to the 5th SEEMIC on the 24-26 September 2013 in Split, Croatia.

Upon the invitation of SEEGROUP – NATO in Brussels the RCC Secretariat presented its achievements in implementation of the RCC SWP 2011-13 and informed on planned activities in the RCC SWP for 2014-16 in the area of Security. Information on the SEEMIC project implementation (DGE) was delivered and different aspects of the future development of SEEMIC were evaluated (EU MS INT).

Third SEENSA Conference was organized jointly and co-chaired by the RCC Secretariat and Albanian National Security Authority. The conference was supported by NATO Office of Security and EU General Secretariat of the Council and provided forum for discussion on the Vision of SEENSA in the future. The participants agreed on specific activities and directions of SEENSA work and confirmed that the TWG and SEENSA will be supported by the NOS, the GS of the EU and RCC Secretariat.

#### 5. Building Human Capital and Cross-Cutting Issues

#### **Education**

The RCC Secretariat organised Regional Workshop – Education in SEE 2020 with the aim to discuss and define regional targets, indicators and measures for the education dimension of the SEE 2020. The participants agreed to slightly modify the 2<sup>nd</sup> target of the Smart Growth pillar of SEE 2020 and defined 2 regional priorities, together with potential measures and activities for realisation of set goals. After received confirmation of the ERI SEE Governing Board, the approved regional priorities, measures and actions were included in the draft SEE 2020.

At the Inaugural Meeting of the Regional Pathfinder Group on Automatic Recognition the participants agreed that intensive cooperation between countries of the region on long term goal of European Higher Education Area on more efficient automatic diploma recognition could provide for new possibilities for setting up a regional model for recognising each other's qualifications.

In the framework of this year's Mobility programme of the RCC Task Force on Fostering and Building Human Capital the RCC Secretariat hosted Junior Adviser in Department for EU Integration/Division for Programming and Implementation of IPA Projects at the Ministry of Education, Science and Technological Development of the Republic of Serbia. The programme was designed as a support measure for middle-level civil servants who are acquainted with and capable of managing regional activities and programmes in education, science and research, and acting as contact points for cooperation and existing networks.

The ETF Corporate Conference 2013 - Torino Process: Moving Skills Forward reviewed the achievements of the Torino Process, identified recent trends and progress in VET

development in the ETF partner countries and identified objectives and the agenda for the 2014 round of Torino Process.

At the Western Balkans Platform on Education and Training (WB PET) Meeting, the Ministers of Education presented the most important activities undertaken by their institutions in order to achieve goals of adopted education strategies at the national level and informed on the national priorities which could be tackled in the framework of regional programmes and activities. WB PET adopted the roadmap of future activities. WB PET aims to assist the transition of the candidates to the membership in the EU and better prepare the potential candidates for their participation in the EU's policy cooperation framework, Open Method of Coordination and integration with the EU Member States.

#### Science and Research

The work on the Regional Research and Development Strategy for Innovation for the Western Balkans has been completed and its adoption is expected at the final Conference of the Ministers of Science scheduled for 24-25 October 2013 in Zagreb. The meeting of the RSRDI Steering committee discussed the organisational aspects of the Ministerial Conference, involving also high representatives of the World Bank, the EC, the RCC Secretariat and other stakeholders.

At the meeting of the Steering Platform on Research for the Western Balkan Countries, in view of the termination of the WBC.INCO.NET (April 2014), all members of the Steering Platform underlined the importance of continuing the policy dialogue with the WBCs beyond the duration of this FP7 project. In this context, the Platform welcomed the possibility outlined by the RCC Secretariat in its presentation of the SEE 2020. It was noted that bringing the current Steering Platform under the auspices of the RCC would increase synergy and unite all actions under one forum. Given the importance of the Steering Platform from a preaccession point of view, the members asked for the possibility of ad-hoc support under IPA and/or 'Horizon 2020' to be considered in order to ensure continuation of the present Steering Platform and the dissemination of information that the WBC.INCO.NET has so far provided through the WBC Newsletter and website.

The RCC Secretariat attended the International Scientific Conference, organised within the framework of the Regional Research Promotion Programme in the Western Balkans (RRPP), gathered around 100 researchers and policy-makers from the field of social sciences in the Western Balkans and Europe. The Regional Research Promotion Programme enables researchers from the region to receive support through research grants, methodological and thematic trainings as well as opportunities for regional and international exchange and networking.

#### Culture

The 6<sup>th</sup> Meeting of the RCC Task Force on Culture and Society (TFCS) focused on the presentation of the Decision of the EC on the financing of the flagship projects from the EU €2.8 mill Grant for Preserving and Restoring Cultural Heritage in the Western Balkans. Important role of the RCC TFCS in the process of selection of flagship projects, demonstrating commitment and ability of the mechanism to get engaged in difficult decision making process, was emphasised. The projects that will be financed are: Apollonia archaeological site in Albania, Kastel Banja Luka in Bosnia and Herzegovina and Franciscan Monastery of Bac in Serbia. During the meeting the zero draft of the Culture and Creative Industries dimension (CCI) of the Smart growth pillar of the SEE 2020 was presented.

The RCC Secretariat has been engaged in the process of exploring the ways for further development of the initiative of establishment of the SEE Museum network. At the meeting with representatives of the Cultural Heritage without Borders (CHwB) – Balkan Museum Network (BMN) project models for possible collaboration between the RCC and CHwB BMN were discussed.

#### **Parliamentary Cooperation**

The 10<sup>th</sup> Conference of the SEECP Speakers of Parliaments, organized in Ohrid by the SEECP Chairmanship-in-Office, decided for the SEECP Parliamentary Dimension to be transformed into the SEECP Parliamentary Assembly – (SEECP PA) as a regular parliamentary forum for exchange of experiences, dialogue and cooperation on issues of interest for the SEE countries. The Conference expressed the confidence that all the steps and documents necessary for convening the constitutive session of the SEECP PA will be finalized during the next SEECP C-i-O. This decision represents an encouraging movement with positive implications for overall regional cooperation in SEE, and it is a clear indicator of regional ownership and responsibility.

Two meetings of Country based Stakeholders Consultations related to the SEE Ombudsmen Agenda, discussed the existing relations between Ombudsmen offices and CSOs, as well as the possibility of establishing of a network of the Ombudsmen offices in the region.

This issue was one of the topics discussed at the Multi-country seminar Relations between Ombudsman institutions and stakeholders organised by DG Enlargement of the EC, TAIEX in cooperation with ReSPA and the RCC Secretariat.

The first meeting of parliamentarians from Contracting Parties - Friends of Energy Community –was co-organised by the RCC Secretariat and Energy Community Secretariat. The conference, aimed to deeper involve Members of Parliaments in the scope of work of Energy Community, was an important recognition of the role of the RCC in the area of Parliamentary Cooperation and reaffirmed the readiness of the Energy Community Secretariat to expand already well established cooperation with the RCC Secretariat in relation to major regional energy and related climate/environmental aspects.

#### IV. Operation of the RCC Secretariat

A remaining open issue related to the setting-up of the RCC Secretariat concerns the implementation of the provisions of the Headquarters Agreement between the Kingdom of Belgium and the RCC Secretariat, which regulates the status of the RCC Secretariat's Liaison Office in Brussels.

The Kingdom of Belgium has conditioned the implementation of relevant provisions of the Headquarters Agreement between the Kingdom of Belgium and the RCC Secretariat providing for the fiscal privileges and immunities of the Head and Deputy Head of the RCC Secretariat's Liaison Office in Brussels with the issuing of an official authentic interpretation concerning the implementation of Article 17.1.(d) of the Agreement between the Council of Ministers of Bosnia and Herzegovina and the Governments of the other SEECP Participating States, the United Nations Interim Administration Mission in Kosovo on behalf of Kosovo in accordance with the United Nations Security Council Resolution 1244, on the Host Country Arrangements for the Secretariat of the Regional Cooperation Council (Host Country Agreement) by the Parties to this Agreement in which the principle of taxability of the officials of the RCC Secretariat in their countries/places of origin and/or permanent residence

would be explicitly confirmed. After a consultation procedure initiated by the RCC Secretary General in August 2008 it became evident that the adoption of an interpretative declaration amending the Agreement would not be acceptable to some of the Parties to the Host Country Agreement, as they consider that such declaration would run counter to the spirit of the current provisions of the Agreement and would lead to its *de facto* amendment. In light of the principles of general international law, the only recourse in this situation would be to proceed with amending the Host Country Agreement accordingly, in light of the request from the Kingdom of Belgium. This, however, remains subject to the will of the Parties to the Host Country Agreement. In this view, the RCC SG sent a communication to the authorities of Bosnia and Herzegovina in early January 2009, proposing to the Council of Ministers of Bosnia and Herzegovina as a Party to and, at the same time, a depositary of the Host Country Agreement to consider the possibility of initiating the process of amending relevant provisions of the Agreement in order to provide for requested confirmation of taxability. This proposal of the RCC Secretary General is still under consideration by the authorities of Bosnia and Herzegovina.

The RCC LO and the Director of the CEFTA Secretariat visited the Director for international organizations in the Protocol of the Belgian Ministry of Foreign Affairs regarding the ratification process of the Headquarters Agreement between the Kingdom of Belgium and the RCC Secretariat (signed in 2008). However, following this visit no further information has been received from the Belgium Ministry of Foreign Affairs.

#### V. Staff Changes in the RCC Secretariat

During the reporting period, the RCC Secretariat has carried out the recruitment process for the following positions: Head of Expert Pool (the contract of the former Head of Expert Pool was terminated on 30 June 2013), Senior Political Advisor, Expert on Infrastructure (temporary replacement for a 7 month period), Head and Administrator of Secretariat of the RCC Task Force on Culture and Society.

The RCC Secretary General, in accordance with his competences and following the recommendation of the selection committee, decided to hire the most suitable candidates to fulfil the posts and all selected officials assumed their duties.

# 2. Support to education reform, with emphasis on higher education

- The RCC Secretariat organised Regional Workshop Education in SEE 2020 Strategy. The aim of the event, gathering members of the ERI SEE Governing Board, representatives of partner organizations and education experts, was to discuss and define • regional targets, indicators and measures for the education dimension of the South East Europe 2020 Strategy. Participants agreed that 2<sup>nd</sup> target of the Smart Growth pillar of SEE 2020 strategy should be changed from Add 300,000 highly educated people to the region's workforce to: Raise the region's workforce by 300,000 highly qualified people. Participants also defined 2 regional priorities, together with potential measures and activities for realisation of set goals. Conclusions of the Workshop were sent for the approval to the ERI SEE Governing Board, as coordinator of education dimension of the SEE 2020 Strategy. After received confirmation of the ERI SEE Governing Board, approved regional priorities, measures and actions were included in the draft SEE 2020 Strategy.

During his stay, he got acquainted with structure of the RCC, the mandate of the BHC Unit and its role in development of South East Europe 2020 Strategy.
