### 3 Important events, meetings, training activities, etc.

### a) Ministerial Meeting of the CEI Ministers of Agriculture, Belgrade 13 May 2011

Mr. Giorgio Rosso Cicogna, CEI Alternate Secretary General in his speech tackled a strategic initiative promoted by the Secretariat on Next Generation Biofuels, i.e. biofuels produced from feedstock, such as agricultural waste or forestry waste. Such project would apply many EC priority "mantras" such as energy, environment, research and development, strengthening SMEs through innovation and export opportunities, and, of course, sustainable agriculture.

### b) CEI Ministerial Meeting on Science and Technology, Trieste 19 October 2011

The Ministers and other Heads of Delegation of the CEI Member States unanimously adopted "The Trieste Declaration" (attached). In this context they referred in particular to the proposed "HORIZON 2020" EU Research and Innovation Programme, stressing the need that the investments in Research Infrastructures should be developed and planned on all available financial instruments. These investments will only be fruitful if a better synergy is achieved with a strengthened support by Horizon 2020 to "open Pan-European Operation" of these infrastructures, supporting "institutional

excellence" alongside and with equal resources and a peer-review based approach as in the action for "individual excellence" already developed by the European Research Council.

# c) CEI Expert Meeting on Next Generation Biofuels and 2<sup>nd</sup> SEDRI Task Force Meeting, to be held in Belgrade on 24 November 2011

Prospects for an integrated and interdisciplinary regional project on Next Generation Biofuels, which represents a priority option for eighteen CEI Member States, is a prominent topic of the first part of the meeting. The second part will be dedicated to SEDRI, a coordination effort of the CEI and the Regional Cooperation Council (RCC) for a joint action in the area of sustainable energy development aimed to maximise the benefits for the Participating countries of SEE by facilitating their access to financial instruments made available by IFIs to support innovative projects in the field of renewable energy.

### 4 Development of international cooperation and actions on integration into ERA

Collecting support at Governmental level as well as from the scientific communities in CEI Member Countries in order to define a dedicated, integrated, interdisciplinary regional project on Next Generation Biofuels, conceived in order to attract several funding instruments from the European Commission to be distributed among beneficiaries according to the status of the respective countries vs. the European Union (EU Members, Candidate and future candidate countries, Neighbours).
